Applications are invited from eligible candidates for the following posts in Railway Protection Force (RPF) and Railway Protection Special Force (RPSF). Applications complete in all respects must be submitted ONLINE ONLY.

Vacancies indicated above and in the CEN are provisional and may increase or decrease in total or in specific units/communities/posts at a later stage depending upon the actual needs of the Railway administration.

- Candidates should ensure that they possess/fulfill all eligibility conditions prescribed for the post(s) as on the closing date for Submission of Application. **CANDIDATES WAITING FOR RESULTS OF PRESCRIBED EDUCATIONAL QUALIFICATION SHOULD NOT APPLY.**
- Physical Measurement (PMT) Standards and Medical Standards:** Candidates must ensure that they fulfill the prescribed PMT and Medical Standards for the post(s) for which they are applying, as detailed in the CENs published on the official RRB websites. Candidates found medically unsuitable for the applied post(s) shall not be given any alternative appointment.
- Reservation and suitability for Persons with Benchmark Disabilities (PwBD):** These posts have not been identified as suitable for persons with disabilities.
- Reservation for Ex Servicemen (ExSM):** For further information, refer to the detailed CENs to be published on the official websites of RRBs.
- Reservation for Women:** 15% of posts are reserved for women. For further information, refer to the detailed CENs to be published on the official websites of RRBs.
- Reservation for SC/ST/OBC/EWS Candidates:** For further information, refer to the detailed CENs to be published on the official websites of RRBs.
- Mode of Examination:** Computer Based Test (CBT) followed by Physical Efficiency Test (PET) and Physical Measurement (PMT). For further details refer to the detailed CENs.

**10.0 Examination Fee:**

1	For all candidates (except categories mentioned below at Sl. No. 2). Out of this fee of ₹ 500/-, an amount of ₹ 400/- shall be refunded duly deducting bank charges as applicable, on appearing in the CBT.	₹ 500/-
2	For candidates who belong to SC, ST, Ex-Servicemen, Female, Minorities or Economically Backward Class (EBC). This fee of ₹ 250/- shall be refunded duly deducting bank charges as applicable, on appearing in the CBT.	₹ 250/-

**NOTE:** Only candidates who attend CBT will get a refund of their examination fee as mentioned above.

11.0 Candidates are required to go through the Post Parameter Table and Vacancy Table of detailed CEN No. RPF 01/2024 and CEN No. RPF 02/2024 to ascertain their eligibility before applying through ONLINE mode. Only one ONLINE application should be submitted by a candidate against each CEN separately i.e., Only one application against CEN No. RPF 01/2024 and only one application against CEN No. RPF 02/2024. Applications should be submitted only through any of the official RRB websites listed in Para 13 below. Any attempt to submit more than one application by a candidate against a CEN shall result in disqualification and debarment.

12.0 **Eligibility:** Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate does not satisfy the eligibility criteria for the post(s), his/her candidature will be rejected forthwith.
